About your lobbyist

Let me introduce myself, I am a member of the Vietnam Veterans of America, a U.S. Army retiree, and a wounded Vietnam Veteran. I am a lobbyist at the state Capitol and have 23 years experience at the Capitol, both as a staff person, policy consultant, and lobbyist. After I retired from my 21 years with the Army in 1986, I went to work for the Legislature. I rose from a staff level position dealing with member services, to policy consultant for several committees, and finally as Chief Policy Consultant in 1995. I also served as Chief of Staff to the late Assemblyman Mickey Conroy for four years.

In 1996 I founded "Pete Conaty & Associates," a lobbying firm which provides clients with expert, knowledgeable, and effective guidance in the complexities of a "term-limited" California State Legislature. Over the past 13 years, I have taken a hands-on approach to developing relationships with new members of the State Legislature and their staffs, while maintaining personal contacts throughout the State Capitol, state agencies, and regulatory bodies.

Besides the VVA, I represent several other military and veteran clients including AMVETS, American Legion, Armed Forces Retirees Association of California, California Association of County Veterans Service Officers, National Association of County Veterans Service Officers, and the National Guard Association of California.

ABOUT LOBBYING

In the era of term limits, it is very important to have a presence at the state Capitol and to take positions on legislation. 28 new legislators were elected in November; this represents a 23 % turnover of the total 120 legislators. This means that almost a quarter of the Legislature has no knowledge of veterans and military issues. Add to this a constant turn over of committees, staff members, consultants, and state agency employees and it is a full time job just keeping track of who is where and then educating them on the issues important to veterans and their families.

One useful tactic that I have developed over the years is to urge my clients to become well known to the Legislature by taking an active role in legislation and policy discussions. The way to do this is to take positions on bills which are favorable to veterans. The client's support

for a bill helps the legislator that is authoring the bill move the legislation forward in the process. The obvious upside of this is that it enables legislation beneficial to veterans to be signed into law. The upside for the client is that it has established that organization as an active participant in the legislative process and that organization now has become a "go to" resource for legislators and staff on all matters pertaining to veterans.

THE 2009 STATE BUDGET UPDATE

On February 20, Governor Schwarzenegger signed a series of bills known as the "budget package", which seeks to address California's \$42 billion deficit. This budget exercise was unprecedented in that it covered an 18 month time period and that it was negotiated by the Big 5. Normally, each budget covers one fiscal year, however the budget that was passed last year fell short due to the troubled economy, therefore the budget package had to also include revisions to the last half of the FY 08-09 budget. The normal budget process was also circumvented and all negotiations occurred between the Governor and the 4 legislative leaders (Big 5).

Some of the highlights of the budget are a 1 cent temporary sales tax increase beginning April 1, an increase in the Vehicle License Fee, increase in income taxes, cuts in school funding and higher education, and cuts to SSI/SSP recipients.

Many aspects of the budget will also be decided by the voters in two upcoming elections. There will be a Special Election on May 19 in which voters will decide whether to create a rainy day fund and extend tax increases, make changes to the state lottery (so the state can borrow against it), shift Prop 63 mental heath funding monies, shift early childhood funding monies, restore monies borrowed from education funding, and eliminate salary increases for lawmakers during tight budget years. During the June 2010 Primary election, voters will decide whether to create the open primary system.

VETERANS AFFAIRS BUDGET

Despite the bleak news on the rest of the budget, the California Department of Veterans Affairs fared fairly well. Veterans service programs were not reduced for the 09-10 budget and the 08-09 mid year budget. The West LA, Lancaster, and Ventura veterans homes remain on track.

SENATE AND ASSEMBLY

VETERANS AFFAIRS COMMITTEES

Both houses of the Legislature have named the full membership of their Committees on Veterans Affairs. Assemblywoman Mary Salas requested and was granted the chairmanship of the Assembly Veterans Committee for 2009. This is the third year that Salas holds this chair. The committee also now has three veterans and one currently serving member of the military. Vice-Chair Paul Cook is a retired Marine Colonel and a Vietnam Veteran. Chuck DeVore is a re tired Lt.Col. from the California National Guard, Danny Gilmore is a former Marine, and Ted Lieu is currently a Major in the Air Force Reserve. Lori Saldana from San Diego will be serving her third year on the committee while Alyson Huber, Manuel Perez, and Mariko Yamada are freshmen legislators joining the committee. Eric Worthen continues to serve as Chief Consultant of the Assembly Veterans Committee.

The Senate Committee on Veterans Affairs has a new chair, Senator Jeff Denham, who is an Air Force veteran with service in Desert Storm and Restore Hope. Senators Lou Correa (Vice-Chair), Negrete-McLeod, Pat Wiggins, and Mark Wyland are long serving members of the veterans committee. They will be joined this year on the committee by Gil Cedillo and Abel Maldonado. The Senate committee was increased in size from five to seven members this year. Donald Wilson remains the Chief Consultant for the Senate Veterans Committee.

Bills are being introduced in large numbers as the bill submission deadline approaches, and we will be studying and tracking bills of interest to the State Council.

VETERAN'S PENSIONS UPDATE

If you are a wartime veteran with a limited income and you are no longer able to work, you may qualify for a Veterans Disability Pension or the Veterans Pension for Veterans 65 or older. Many veterans of wartime service are completely unaware of the fact that if they are 65 or older and on a limited income they may qualify for a VA Pension without being disabled. An estimated 2 million impoverished veterans and their widows are not receiving the VA pension they deserve because they do not know about it. The VA has had limited success in getting the information to them. Generally, you may be eligible if:

• You were discharged from service under conditions other than dishonorable, and

 You served at least 90 days of active military service 1 day of which was during a war time period. If you entered active duty after September 7, 1980, generally you must have served at least 24 months or the full period for which called or ordered to active duty (There are exceptions to this rule), and

 Your countable family income is below a yearly limit set by law (The yearly limit on income is set by Congress), and

 You are age 65 or older, or, you are permanently and totally disabled, not due to your own willful misconduct.

With the advent of the Gulf War on 2 Aug. '90 (and still not ended by Congress to this day), veterans can now serve after 2 Aug. '90 during a period of war time. If your countable income appears to be near the maximum you should apply. VA will determine if you are eligible and notify you. If you do not initially qualify, you may reapply if you have un-reimbursed medical expenses during the twelve month period after VA receives your claim that brings your countable income below the yearly income limit (i.e. These are expense

you have paid for medical services or products for which you will not be reimbursed by Medicare or private medical insurance). Countable income for eligibility purposes includes income received by the veteran and his or her dependents, if any, from most sources. It includes earnings, disability and retirement payments, interest and dividends, and net income from farming or business. There is a presumption that all of a child's income is available to or for the veteran. VA may grant an exception to this in hardship cases. There is no set limit on how much net worth a veteran and his dependents can have, but net worth cannot be excessive. Net worth means the net value of the assets of the veteran and his or her dependents. It includes such assets as bank accounts, stocks, bonds, mutual funds and any property other than the veteran's residence and a reasonable lot area. The decision as to whether a claimant's net worth is excessive depends on the facts of each individual case. All net worth should be reported and VA will determine if a claimant's assets are sufficiently large that the claimant could live off these assets for

a reasonable period of time. VA's needsbased programs are not intended to protect substantial assets or build up an estate for the benefit of heirs. The Maximum Annual Pension Rates (MAPR) effective 1 Dec. '08 for both living and deceased veteran's

Some income is not counted toward the yearly limit (for example, welfare benefits, some wages earned by dependent children, and Supplemental Security Income). It's also important to note that your medical related expenses are considered when determining your yearly family income. VA pays you the difference between your countable family income and the yearly income limit which describes your situation. This difference is generally paid in 12 equal monthly payments rounded down to the nearest dollar. You can apply by filling out VA Form 21-526, Veteran's Application for Compensation Or Pension. If available, attach copies of dependency records (marriage & children's birth certificates) and current medical evidence (doctor & hospital reports). LEGISLATION TO SECURE TIMELY FUNDING FOR VETERANS' HEALTH CARE

House and Senate Veterans' Affairs Chairmen joined by bipartisan cosponsors, major veterans' organizations and a former VA official in calling for passage

WASHINGTON, D.C. - U.S. Senator Daniel K. Akaka (D-HI), Chairman of the Veterans' Affairs Committee, was joined by a bipartisan group of lawmakers in reintroducing legislation today to secure timely funding for veterans' health care through the advance appropriations process. **Chairman Akaka joined House Veterans' Affairs** Chairman Bob Filner (D-CA), other members of Congress, leaders from military and veteran orcanizations, and a former VA executive in calling

for prompt consideration of the Veterans Health Care Budget Reform and Transparency Act of 2009.

Under the bill, the Veterans Health Administration (VHA) would be funded one-year ahead of the regular federal funding process. Currently, VHA's budget is subject to delay and uncertainty, hampering budget planning and threatening health care quality for wounded and indigent veterans. The Veterans Health Care Budget Reform and Transparency Act has already received broad support from its Democratic, Republican, and Independent sponsors in Congress.

Senator Akaka said: "We are a step closer towards securing timely, predictable funding for the nation's largest health care system - the Veterans Health Administration. Our plan would create a transparent process that will help VA use its funding more efficiently and care for veterans more effectively than it has in the past. I am proud to be joined by a bipartisan group of Congressional leaders and major veterans service organizations in calling for an end to VHA's unpredictable funding."

Congressman Filner said: "I appreciate the sentiments of Secretary Shinseki to approve and implement future VA budgets on time, but we must also recognize the various obstacles that frequently prevent this from happening. This bill is a way to explore a new manner in which to fund the VA. We need to consider a historic new approach to guarantee that our veterans have access to comprehensive, quality health care that they deserve and have earned. For too many years, VA has had to make do with insufficient budgets resulting in restricted access for many veterans. When funding is short, it is our veterans who pay the price."

Senator Olympia Snowe (R-ME) said: "The breakdown in the process of providing funding for our veterans has a bipartisan history spanning over two decades - under Republican and Democratic control of the White House and Congress. However during this time, health care funding for veterans has only been approved on schedule three times! This is unconscionable. With this bipartisan initiative, we can ensure our veterans and their families truly benefit from the healthcare that these patriots have rightfully earned and deserve."

Senator Jon Tester (D-MT) said: "It's about time we take the uncertainty out of the annual funding for VA health care. Making sure all veterans have access to quality, affordable health care so they don't have to come to Congress every year with hat-in-hand is a promise we owe all men and women who served in uniform."

Congressman Phil Hare (D-IL) said: "Like the mandatory funding legislation I introduced in the last Congress, advanced appropriations is the means to an end. That end is ensuring veterans receive the best care possible from a VA that has access to timely, sufficient, and predictable resources. I enthusiastically support this bill and commend Chairmen Akaka and Filner for introducing it."

Senator Mary Landrieu (D-LA) said: "One of the best ways we can honor the service of our brave veterans is by providing them with the highquality health care and services they need. Advance funding for veterans health care will allow the VA to make strategic budgetary decisions that will improve the care provided to our veterans.'

Senator Bernard Sanders (I-VT) said: "The VA needs to receive its budget in advance so it can hire the right number of staff to take care of our veterans without waiting for Congress to pass their spending bill. How

can we expect the second largest agency in the federal government, which provides health care to over 5.5 million people, to function when they don't know when they will get their budget? That is why the time for advanced funding for the VA has come. I look forward to working with the president, Secretary Shinseki, Chairman Akaka and our nation's veterans' service organizations to make sure this bill is signed into law this Conaress."

Senator Mark Begich (D-AK) said: "Our veterans deserve to know that they will receive the health care they need in a timely and predictable fashion. This is just one small way we can thank them for their service to our country. By authorizing two-year budget authority for the VA, the nation's largest health care provider will have the funding and stability to adequately plan and prepare to deliver a level of service and care that our nation's veterans so richly deserve and have so honorably earned."

Senator Frank Lautenberg (D-NJ) said: "We owe our veterans and their families the best quality care we can provide. Our soldiers and sailors do their duty to protect America, so it's our duty to provide for them when they return home.³

Senator Barbara Boxer (D-CA) said: "Setting funding two years in advance will help ensure that no veteran is ever turned away, and I am pleased to support this important legislation introduced by Senator Akaka.'

Congressman Mike Michaud (D-ME), Chairman of the House Veterans' Affairs Subcommittee on Health, said: "Too often in recent years, VA has been funded after the beginning of the fiscal year and in one case, so underfunded that they required a supplemental appropriation. This cannot be allowed to occur when we are dealing with the health care of our veterans. There must be a timely, sufficient, and predictable funding stream for VA health care. That is what this legislation will achieve."

Senator David Vitter (R-LA) said: "Veterans' health care is a particularly important issue, and as our servicemembers return from combat theatres in Iraq and Afghanistan, the Veterans' Administration has seen a significant growth in demand for health services. Historically, the VA's health care budget has been delivered late, and appropriations levels have been often too low. This bill would allow the VA to plan better by allowing appropriations to be made for the upcoming and following fiscal years."

The Veterans Health Care Budget Reform and Transparency Act is supported by the Partner-ship for Veterans Health Care Budget Reform, a coalition of major veterans service organizations including The American Legion, AMVETS, Blinded Veterans of America, Disabled Veterans of America, Jewish War Veterans, the Military Order of the Purple Heart, Paralyzed Veterans of America, Veterans of Foreign Wars, and Vietnam Veterans of America. The bill received unanimous support from a panel of six veterans organizations at a recent Senate hearing.

HEALTHCARE **L**EGISLATION

Ask Your Member Of Congress To Support Advanced Funding for Veterans Health Care Take Action!

H.R. 1016 and S. 423

Nine of the largest national veterans organizations, including VVA, joined by a coalition of 35 other veterans and military organizations, and the nation's largest federal union, praised Senate and House Veterans' Affairs Committee leaders for introducing bipartisan bills on February 12, 2009 to reform the VA budget process that would assure sufficient, timely and predictable funding for veterans' health care programs. This new legislation, the Veterans Health Care Budget Reform and Transparency Act, would require Congress to approve health care funding for the Department of Veterans Affairs (VA) a year in advance of the beginning of its fiscal year.

The Partnership for Veterans Health Care Budget Reform (http://www.fundingforvets.org) worked closely with the bill sponsors in drafting this key legislation. The bill will guarantee no further delays in VA health care funding, and will break the cycle of perpetually late budgets that has disrupted operations and delayed veterans' care in the nation's largest health care system 19 of the past 22 fiscal years. While VA health care funding has increased in recent years, especially the last two years, it is still consistently late, and often months late.

The Senate bill (S. 423) was introduced by Veterans' Affairs Committee Chairman Daniel Akaka (D-HI), and co-sponsored by Senators Olympia Snowe (R-ME), Tim Johnson (D-SD), Jon Tester (D-MT), Mark Begich (D-AK), Jeff Bingaman (D-NM), Barbara Boxer (D-CA), Russ Feingold (D-WI), Mary Landrieu (D-LA), Frank Lautenberg (D-NJ), Robert Menendez (D-NJ), Lisa Murkowski (R-AK), John D. Rockefeller (D-WV), Bernard Sanders (I-VT), Debbie Stabenow (D-MI), John Thune (R-SD), and David Vitter (R-LA).

The House bill (H.R. 1016) was introduced by Veterans' Affairs Committee Chairman Bob Filner (D-CA), and co-sponsored by Representatives Walter Jones (R-NC), Phil Hare (D-IL), Stephanie Herseth Sandlin (D-SD), Mike Michaud (D-ME), and John Hall (D-NY).

What is needed now, more than ever, is a grassroots effort. It is critically important that VVA members – and your families – reach out to your Senators and Member of Congress. Ask them how they stand on the issue of funding for veterans' health care. If they profess their support for sufficient, timely, and predictable funding, ask them not only to support, but to co-sponsor H.R. 1016/S. 423. If they agree, thank them. If they demur, raise the heat – at town hall meetings and via letters and e-mails.

Achieving sufficient, timely, and predictable funding is VVA's highest legislative goal. With the support of the President, it is within reach. And your efforts can make a difference.

PRESIDENT'S MESSAGE Bob Johnston, Sr., March 2009

It has been a very busy time since my last Message in the Zephyr. During that time I have traveled extensively back and forth to Sacramento, attending planning meetings for the December 2008 20th Anniversary Celebration of the California Vietnam Veterans Memorial Dedication. In addition I have traveled, visiting chapters and attending other meetings and functions, representing the State Council.

Of course, the big event was the 20th Anniversary event in Sacramento in December. Regrettably due to a personal family tragedy, my plans to be in Sacramento at the beginning of the events were postponed and I didn't arrive until very early Friday morning. However, I hit the ground running that morning, attending the Press Conference at the CDVA Bldg. I spent Friday afternoon getting ready for the CSC Sponsored Recognition Dinner for the Original Memorial Commission later that night. The evening's activities were a success and we accomplished our mission of paying respect and giving recognition to the California Vietnam Veterans Memorial Commission, and all those sponsors who helped us put on the Anniversary event.

The parade on Saturday morning was quite impressive, with over 50 participates, including marchers from all over the state and a few out of state. There were two helicopters on flatbed trucks, adding an icon presence to the parade. There were several chapters from throughout the state with Color Guards and marching units. It was my Honor and Privilege to lead the State Council contingent, consisting of several members of the Board of Directors and other members of the CSC and CA AVVA. Despite less than hoped for pre-event publicity and coverage by the local media, it was well attended by spectators along the route.

The Dedication Anniversary Program, held in front of the Memorial was also well attended by Veterans of the Vietnam War, and other American Military wars and conflicts, families, friends, and those who came just to pay respect and honor those to whom the memorial is dedicated. It was MC'd by Stan Atkinson and included speeches by Vietnam Veteran Medal of Honor recipient and Former POW Jon Cavianni, Chairperson of the original California Vietnam Veterans Memorial Commission Sister Linda McClennahan - Vietnam Veteran, BT Collin's sister Maureen Collins, American Legion National Commander Dave Rehbein - Vietnam Era Veteran, VVA National Vice President Jack Devine - Vietnam Veteran, and Vietnam War Journalist Joe Galloway - la Drang Valley Veteran.

Secretary of California Department of Veterans Affairs Tom Johnson - Vietnam Veteran, presented me with a framed copy of the California State Legislation, ACR 151, which declared December 10 thru 15, 2008, as the official state "Welcome Home Vietnam Veterans Week". Following the Program was a USO-Style Entertainment Show, featuring music from the Vietnam Era, which was enjoyed by all.

Sunday morning brought the end of the activities with a Sunrise POW/MIA Ceremony at the Memorial, which concluded with the release of 178 black and white balloons, representing each of the Californians who are listed as POW/MIA.

In January, I attended the VVA Conference of State Council President's meeting in Oklahoma City, OK, where we discussed several important issues that had been raised at the VVA National Board of Directors meeting the previous weekend. National President John Rowan was there to address the meeting, and respond to questions. Special arrangements were made by the Oklahoma State Council that resulted with us going to the NBA Oklahoma City Thunders' game against the Detroit Pistons on Friday evening. On Saturday afternoon, we traveled to the local VA Hospital and visited with the patients there. A special show was done by Bleu Eyed Soul, for the wounded warriors there.

The January CSC meeting was very successful, with workshops on the CSC Budget for Committees and the BOD, and also on Chapter Incorpo-

in Sacramento, presented by Finance Committee Chair Barry Schloffel and myself. This workshop was presented as a result of a new policy from the VVA National Board of Directors, passed at their January meeting, requiring each State Council President to file an annual report, listing chapters who are not in compliance with Federal and State Non-Profit laws and regulations, by Feb. 28th. During the check of CA State records in Sacramento, several chapters were found not to be current in their filing with either the Secretary of State's Office or the Office of the Attorney General, Registry of Charitable Trusts. Barry Schloffel was tasked with overseeing this issue, and working together with the District Vice Presidents, and has gotten most of the chapters updated and corrected where needed. There are still a few chapters who need their California Incorporation and Non-Profit status brought current and Barry is continuing to work on that.

On February 12th, I had the solemn duty and Honor to represent the CSC in Lakeport, at the Memorial Services for Barnett Hoffman, past CSC Finance Committee Chair. The service was well attended by family, friends, and fellow veterans from many organizations. Chapter 951, which Barnett was instrumental in helping to form, provided assistance and help in paying respect to their fallen Brother. Also in attendance from the CSC were Ken Holybee, Henry lasiello, Kate O'Hare Palmer and my wife Barbara.

The CSC has entered into the California State Legislative Issues arena, with the hiring of Pete Conaty, a licensed Legislative Lobbyist and VVA member, to represent us in Sacramento before the state legislature regarding veterans' issues, and advising us on proposed legislation which affects veterans' affairs. He is working under the Government Affairs Committee, and will be presenting a workshop at the April meeting on the workings of a Lobbyist.

Chapters will be holding elections of Officers and Board Members in April, as required by the VVA National Constitution. To help chapters with the election process, a workshop will be held at the April CSC meeting, to discuss this and the upcoming 14th VVA National Convention. It will be held in Louisville, KY, July 27th thru August 2nd. Early registration of Chapter Delegates must be postmarked by June 15, 2009, after that delegates must register on site at the convention. As in the past, Regions 8 & 9 will be holding a Pre-convention joint conference in Reno, NV. June 12th to 14th, at the Silver Legacy Resort. Additional information on these events are available on the CSC and National Websites.

Due to personal matters, Ed Mentz Jr. resigned from his position as Chair of the CSC POW/MIA Committee. This leaves that committee chair vacant. If there are members who are interested in being considered for that position, please contact me by email at BobJ201@yahoo.com. I would like to be able to announce the new POW/ MIA Chair at the April CSC meeting.

I look forward to seeing all of the Chapter Delegates at the April meeting, and hope that other chapter members will also attend, to see what happens at our meeting, and get an understanding of the workings of the California State Council.

VETERANS INCARCERATED Bob Chaney

To all the incarcerated veterans who are reading this column, I am in the process of compiling a list of all contacts for each prison, and camp. You can be of assistance by having your sponsors and/or contact persons forward their names and addresses to me at the following address: Veterans Incarcerated, PO Box 3007, Riverside, CA 92519. I also have a number of 20th Anniversary Books from the California Vietnam Veterans Memorial that I would like to

send to your library. Please forward the name and address of your Senior Librarian or Community Resource Manager to the aforementioned address. More news, there are two major bills dealing with the incarcerated veteran being introduced in the state legislature this year. They are AB589, which allows the Department of Corrections and Rehabilitation or local law enforcement agency to contract with County Veterans Service Officers in the county where the state or local correctional facility is located to assist an incarcerated honorably discharged veteran and veteran's dependent's in presenting and pursuing any VA claims. AB1013 requires the Department of Corrections and Rehabilitation to conduct an interdisciplinary assessment of new inmates who have combat experience with the United States military, or are on active duty, reserve, or National Guard status and to develop specialized treatment protocols for those inmates. I will keep you updated on these two bills through this column.

From time to time you will see information about homeless veterans in this column. Homelessness and the Incarcerated Veteran go hand in hand. Many times the veteran is incarcerated because of a homeless issue, returned to prison because he/she cannot find temporary housing while trying to find employment. This year there is one bill in the legislature that should be watched. It is AB710 the Veterans Housing and Assistance Program. It establishes the veterans housing and assistance program, under which the Department of Housing and Community Development would be authorized to make grants from the Veterans Housing and Assistance Fund, to local governments and nonprofit organizations to provide emergency or temporary housing for homeless veterans.

At present there are 63 assembly bills dealing with veterans issues. I am sure you will see many articles on these bills in the coming issues of the Zephyr. I will continue to keep you informed on the Incarcerated and Homeless legislative issues in this column. In closing, I am requesting that all sponsor/contact information be submitted before June 30, 2009

VETERAN SERVICE OFFICERS LONG BEACH VAMC, CA

On February 4th I went to the Long Beach Veterans Hospital (LBVH) to spend a little time and inspect the office facilities and to talk with our two VSO's. I arrived about 10:00 AM and found that Karen Olszewski was busy with one of her clients and a waiting room of six more veterans waiting to see her. Her clients sign in on a sheet she maintains outside her office. I spoke with one Vietnam veteran scheduled about third down the list and asked him why he didn't just see one of the other VSO's from a different service group. He responded that she has the reputation of being the best and he feels very comfortable talking to her.

I apologized to the next in line and crowded in so Karen and I could talk. She showed me her office and desk computer. She explained a program (I believe it was called Vet Pro) that one of the State employees used and wanted to see if we could acquire. I told her to find out where to purchase and let Dick Southern, our Chief Service Officer, know her desire and we would move in that direction if the cost was warranted. She had been working on a spreadsheet to list all her clients and asked that I help with the Excel program to establish tabs for each alphabet. The current total equaled about 1145 listed. I showed her how to accomplish the task without reviewing confidential information by merely merging each separate file to one spreadsheet file with the 26 tabs. She proceeded to show me her office where she had one tall cabinet with client information. Additionally she showed me another office where extra hard copy files are maintained in a locked room and well secured locked cabinets.

THE LAST HOUSE ON THE BLOCK Matt Davison - AVVA Chapter 53

In 2006, I was coordinating a pilot program for the Department of Labor, called the Incarcerated Veterans Transition Program (IVTP). Since this was a pilot program, the there was always the option that the Department of Labor could discontinue it. In the Fall of 2007, I got word that IVTP was being terminated. Knowing that the non-profit I was working for at the time could not afford to keep me on the payroll without this funding, I thought about where I would most like to continue my service to veterans. I had known about New Directions, Inc. They had an excellent reputation for their holistic approach to serving veterans in need and at risk. Fortunately, there was an opening. More fortunately, I was able to fill that opening.

The moment you enter the center, you will see the mural "Healing," created by artist Lucia Vinograd, which covers the circular exterior of the building's first floor conference room. The mural incorporates selected lines from Wendell Berry's essay of the same name, and symbolizes the journey undertaken by many of the residents here. Veterans who traveled from combat to addiction to homelessness find at New Directions a family of healing and renewal. When I saw the mural and read the words, I knew I was home.

New Directions offers a range of services for veterans who are homeless or at risk of becoming homeless; these include long-term transitional housing, substance abuse treatment, mental health and PTSD support, counseling, remedial education, vocational training and employment assistance, family reunification, par-



enting classes, and help in obtaining permanent housing. Currently being served are chronically homeless veterans, both men and women, veterans diagnosed with substance abuse, mental illness or both, veterans returning from Operation Enduring Freedom (OEF) and Operation Iraqi Freedom (OIF). Permanent supportive housing is being developed for disabled veterans, both older men and women, and OEF/OIF veterans.

New Directions began in 1972, when John Keaveney returned to the U.S. after serving two tours of duty in Vietnam. Suffering from untreated PTSD, John soon fell into a vicious cycle of abusing drugs and alcohol, becoming homeless, and spending 11 years in and out of prison. In 1983, John was court-mandated to a Veterans Affairs drug rehabilitation program called New Directions. In 1990, John partnered with Larry Williams and Toni Reinis, a public policy advocate who had developed programs and services for homeless people in the community. In 1992, John, Toni and Larry established New Directions, Inc., a nonprofit 501 (c) (3) organization named after the VA program that saved John and Larry's lives.

In 1994, New Directions became the first social service agency in the Nation to establish a residential treatment program designed for female veterans dealing with issues of homelessness, trauma and addiction. Known as "The Last House on the Block", the 3-story building located on the West Los Angeles VA campus houses up to 156 male veterans, a 24-bed detoxification and assessment center, dining room and kitchen, employment center, gymnasium, and classrooms for remedial education, computer training and construction management. Another building on campus is geared to veterans with co-occurring mental illness and substance abuse disorders. In 2007, New Directions partnered with A Community of Friends to sign a 75-year lease for two buildings on the Sepulveda VA campus in North Hills. These structures will be developed into 147 units of permanent supportive housing to serve the needs of disabled veterans.

It all begins with Outreach. Staffed by veterans, the Outreach team visits parks, skid row, recreational areas, jails and prisons, shelters and VA medical centers. They accompany incarcerated vets to court hearings in the hope of securing their release into our custody and into the New Directions detox center for assessment. Earnest is the spiritual centerof this team. He watches out for their safety and brings harmony to places of great despair. The Employment Center empowers veterans to return to families and society. Some of these veterans face significant barriers such as felony convictions, mental

health issues or spotty job histories. Nevertheless, the New Directions vocational team has been highly successful in helping these individuals return to the workplace. In addition to Employment Services, the Education Services, in partnership with the Los Angeles District's Adult Division, teaches reading, writing, and mathematics to veterans since 1997.

New Directions even has its own choir that travels around California and brings joy to all who attend their performances. They say that when one door closes, another door opens. The door that opened for me over a year and a half ago opened wide and welcomed me home. The veterans of New Directions are turn-

ing their lives around, and I feel honored to assist. To quote Wendell Berry...

The most creative works are all strategies of health. Good work finds the way between pride and despair. It graces with health. It heals with grace. By it, we lose loneliness: the scattered members must be brought together.

January ended on a sad note for Chapter 951. Founding member and Treasurer, Barnett Hoffman passed away on Friday, January 30th. Barnett returned home on Thursday, January 22, from the San Francisco VA Medical Center. Barnett was under the care of his family, friends, and Hospice of Lake County. Barnett passed away peacefully surrounded by his family and friends.

Barnett was initially hospitalized on December 22nd, 2008. Sutter-Lakeside Hospital in Lakeport, CA stabilized Barnett until he was well enough to be transported to the San Francisco VA Medical Center. Under the care of the VA, Barnett improved dramatically. Barnett used to tell me how much he hated the SFVAMC; however, he had nothing but good words for the care that the staff provided. He commented to me that he particularly enjoyed the bath, shaving his beard, and shaving his head. I visited Barnett on January 4th, the afternoon after his arrival. "Cue-ball" was in good spirits, off the ventilator, and wanted to talk about our chapter's next project-"The Moving Wall."

On a personal note, Barnett and I had an interesting relationship. Despite our cantankerous, contentious/head butting style, we had a deep relationship (OK, I did threaten to cut his oxygen tube a few times). Barnett and I shared the goals of the VVA organization; we supported one another in times of turmoil; we trusted each other and we had each other's back.

The last conversation that Barnett and I had illustrates our bond. On the morning of Thursday, January 22, Barnett called me from his bed at SF-VAMC. He said "Dean, I am coming home to die". He then talked about his one request—put a picture of our "Moving Wall" on his grave. I made Barnett make an agreement with me: he would walk "point" for us. The last words that Barnett said to me were "Love you, Bro"

Barnett was instrumental in the formation of Chapter 951. Barnett, Terry Rose, and Randy Sutton initiated the necessary steps to form the chapter. Ken Holybee and Henry lasiello provided the necessary information and charter requirements. Barnett, Terry, and Randy put out the word that a VVA chapter was forming. An advisory meeting occurred on December 7, 2004. Seventeen Vietnam veterans attended the initial meeting. Five weeks later, Chapter 951 was born.

Barnett was a strong supporter of veterans and VVA. Prior to the formation of Chapter 951, Barnett was a member of Santa Rosa Chapter 223. Barnett cared deeply about homeless and/or challenged veterans; he insisted that outreach be a chapter priority. Barnett's knowledge and experience with VVA was invaluable to the progress of Chapter 951. Barnett served the chapter with honor and distinction.

On Thursday, February 12th, a Memorial Service for Barnett took place at our chapter meeting location - the Parish Hall of St. Mary Immaculate Church. Over one hundred guests and family attended a traditional Jewish Memorial Service. The attendee's represented a broad spectrum of people. Tax clients, Rotary friends, VVA chapter members, friends in the community, and family members from all over the country gathered to honor and respect Barnett. Special thanks to representatives of the California State Council who attended the service: CSC President Bob Johnston and wife, Bobbie, CSC 1st Vice-President Ken Holybee, and Northern District Vice-President Henry lasiello. Thompson awards local man's efforts in health care for veterans

Even after he has long retired from the service, veteran Jack Alderson continues to fight for the men who fought with him.

A former member of the United States

Navy, Alderson has been working for the last 10 years to ensure that his men and others affected by covert biological and chemical weapons testing done by the Department of Defense during the 1960s and 1970s get the health care they deserve.

Alderson was the commander of a group of light tugboats in the northwest Hawaiian Islands during the testing.

"For him, it's not really about him, it's about the men he still feels responsible for," Alderson's daughter Sheree Shapiro said Friday after North Coast Congressman Mike Thompson presented her father with a surprise award at the Rotary Club of Southwest Eureka's luncheon. Shapiro said when her father retired about 10 years ago, the cause became his full-time job.

"This guy's a real hero," Thompson said as he was presenting the award acknowledging Alderson's hard work and dedication.

"We've got a lot more to do and I want you there by my side," Thompson said before the room gave Alderson a standing ovation. The Rotary Club added to the award by donating \$200 to Disabled American Veterans in Alderson's and Thompson's names, adding that they were taking additional donations from any members who wanted to contribute as well.

Thompson said it was only with Alderson's help that he and Congressman Denny Rehberg, R-Mont., were able to introduce the bill that provides health care to veterans subjected, many unknowingly, to biological and chemical weapons tests. Until several years ago the Department of Defense never admitted the tests took place.

The tests were conducted by the Department of Veterans Affairs, who now have to assume that the toxins used in the weapons tests of Project 112 – which included classified military operation Project Shipboard Hazard and Defense, or Project SHAD, in which chemical and biological agents such as VX nerve gas, sarin nerve gas and E. coli were tested with the help of Alderson and his crew – caused injury to veterans, making them eligible for medical benefits and compensation for their conditions.

A Ferndale resident, Alderson himself has experienced malignant melanoma, prostate cancer and high blood pressure, which he believes were the direct result of Project SHAD.

Shapiro said she is immensely proud of her father who continues to respect his country and government to this day despite what happened to him.

Wearing a tie featuring tiny anchors and the words, "Don't give up the ship," Alderson accepted the award and said he wants to continue fighting for the rights of all those affected by the

covert tests, including the widows of men who have died from ailments linked to the tests.

Alderson said he continues on because of his men and their dedication to their duty and praised Thompson for his willingness to listen and work with him.

"I have so much respect for the Congressman Mike Thompson. We owe him a lot," Alderson said.

CONCORD AND KHE SANH January 22, 2009

In his inaugural address, President Barack Obama summoned the memories of epic American fights for freedom, reciting battle sites that every school child knows: Concord. Gettysburg. Normandy. But he added one that has not ranked among those famous battles of the American Revolution, the Civil War and World War II.

"For us," he said, "they fought and died, in places like Concord and Gettysburg, Normandy and Khe Sanh."

The siege of Khe Sanh, in the first months of 1968, was one of the bloodiest battles of the Vietnam War. It lasted 77 days and claimed about 200 American lives, according to official U. S. figures. Some accounts put the death toll much higher. The siege, and the Tet Offensive that started around the same time, helped turn American public opinion against the war.

Obama's reference to Khe Sanh was brief, but it was probably noticed by millions of Americans some who fought in the war, some who protested against the war, and some who just remember that agonizing time in American history.

In listing Khe Sanh with three epic battles for American freedom, Obama as much as said: We're past one generation's long political divide over Vietnam. What we remember, what we honor, is the sacrifice of more than 58,000 American

soldiers who died and tens of thousands who were wounded.

That was a nice touch in a fine speech summoning Americans to find courage for the days—and battles—ahead.

Perhaps Obama included that reference out of respect for the man he beat for the presidency, Sen. John McCain, whose resilience and courage as a Vietnam prisoner-of-war has inspired many Americans.

One sentence in one speech won't lay to rest the lingering political divide over Vietnam. But did you notice that this campaign for president avoided the "what did you do during the Vietnam War" political harangues of recent campaigns?

There were no questions about draft dodging, which Bill Clinton faced in 1992. No questions, as Sen. John Kerry faced in 2004, about his service record on a swift boat and his protests against the war. No questions, as Dan Quayle faced in 1988 and George W. Bush faced in 2000, about whether joining the National Guard was a dodge.

Not that Vietnam was entirely absent. Republicans tried to make an issue of war protester William Ayers' ties to Obama. But the issue was Ayers' radical tactics, not his opposition to the war.

Maybe this is the reason that the politics of Vietnam was blessedly missing from the politics of campaign 2008:

McCain served with unquestioned distinction and has been a leader in achieving reconciliation both with Vietnam and within our own country.

Obama, like many voters, was too young to serve in that war or march in protest. For them, it's all ancient history.

Whatever the reason, it was a relief.

Concord, Lexington, Normandy, Khe Sanh. We honor those who gave their lives.


