Linda Sanchez Introduces Legislation Honoring Vietnam War Veterans

Washington, DC = ADCongresswoman Linda T. Sanchez=20 has introduced legislation (H. Res 184) giving=20 long overdue recognition to thousands of Vietnam=20 War veterans by designating March 30, 2011 as=20 "Welcome Home Vietnam Veterans Day". March 30 is=20 intended to commemorate the day when the last=20 U. S. combat troops completed their service and left Vietnam

"When our troops returned from Vietnam after=20 honorably serving our country, too many of them=20 never received a proper homecoming", said=20 Congresswoman Sanchez. "Many returning veterans=20 faced hostility, harsh ridicule, and criticism=20 from the American public. We owe it to these=20 veterans to honor them for their dedicated service to our country".

Congresswoman Sanchez, a member of the House=20 Veterans' Affairs Committee, has introduced this=20 resolution every Congress since she was elected=20 in 2002. "Welcome Home Vietnam Veterans Day" has=20 received broad bipartisan support by the House of=20 Representatives after Congresswoman Sanchez=20 introduced it in the 108th, 109th, 110th, and 111th Congresses.

Local veterans, in cooperation with Congresswoman=20 Sanchez, host a Welcome Home Vietnam Veterans Day=20 Celebration event annually in her district. LEGISLATIVE REPORT

The 2011-2012 California Legislative Session is underway. The state's dire fiscal crisis and the formulation of the state's Fiscal Year 2011-2012 budget is overshadowing all other legislative business. The new Governor and the Legislature hope to reach agreement on a budget plan in time to qualify an initiative for the June ballot which will ask the voters to extend the \$12 billion of temporary tax increases initiated a few years ago. Amidst this budgetary furor, the annual cycle of legislation is proceeding in the background. Currently, we are tracking 59 pieces of state legislation regarding veterans and military related issues. My office has been working with the Council's Legislative Chairman, Ken Holybee to take positions on these bills.

The council is sponsoring two bills (see below). Please bring these bills to the attention of your local legislator and ask for their support on them when they come up for

AB 167 (Cook), California Stolen Valor Act

- Names the existing law which provides that any person who falsely represents himself or herself to have been awarded any military decoration, with the intent to defraud, is guilty of a misdemeanor as the California Stolen Valor Act.
- · Requires that certain elected officers forfeit their office upon conviction of a crime pursuant to the California Stolen Valor Act, that involves a false claim that the person is a veteran or a member of the Armed Forces AB 201 (Butler), Veterans Courts
- · Authorizes superior courts to develop and implement veterans courts for eligible veterans of the U.S. military with the objective of, among other things, creation of a dedicated calendar or a locally developed collaborative courtsupervised veterans mental health program or system that leads to the placement of as many mentally ill offenders who are veterans, including those with post-traumatic stress disorder, traumatic brain injury, substance abuse, or any mental health problem due to military service.

Also, a very important bill is AB 1209 by Assemblyman Paul Cook (R-Yucaipa). Mr. Cook, Chairman of the Assembly Committee on Veterans Affairs and retired USMC Colonel has introduced AB 1209 which seeks to restore the full funding for the County Veterans Service Officers (CVSO's) and the Veterans Re-integration Project, aka Operation Welcome Home (OWH). The \$600,000 set aside for grants to Veterans Service Organizations (VSO's) is part of this funding which we are working to

During January and February the fight to restore the funding for CVSO's/OWH took place in the legislative budget process. However, on March 2 the Joint Legislative Conference Committee took action which resulted in the funding currently allocated for CVSO's/OWH to be reduced by \$5 million and for the next Fiscal Year's funding to be \$2.6 million for CVSO's only. This is the same level of funding the state has been allocating since 2006. For all practical purposes, this is the same amount the state has been allocating since 2000. In other words, the level of funding found to be sufficient during peace time in 2000 is the same level of funding the state feels is sufficient to assist the swelling numbers of veterans being discharged from OEF/OIF service.

During the January and February budget fights, the VVA-CSC and other major California veterans service organizations were fully engaged in urging the Legislature and the Governor's office to fully fund the CVSO's/OWH programs. The key budget sub-committee hearings were attended by numerous veterans leaders and individual veterans from the surrounding area. Theirs and my own testimony and attendance was invaluable in showing the support of the veterans community.

Legislators who went above the call of duty in helping us fight to restore the funding were:

Senator Mike Rubio (D- Bakersfield), Senator Doug La Malfa (R-Butte), Assemblywoman Joan Buchanan (D-San Ramon), Assemblyman Jim Nielsen (R-Biggs), Assemblyman Don Wagner (R-Irvine), and Assemblyman Dan Logue (R-Chico).

Therefore, the battle we must now fight going forward is to convince the Legislature and Governor to fully fund the CVSO / OWH budget. Assemblyman Cook's AB 1209 is now the legislation to rally around in the battle to restore the CVSO / OWH funding!

To give the bill the political punch needed to effect this

change we need to get as many of Mr. Cook's fellow legislators to join him as co-authors on the bill. To date the following legislators have joined as co-authors on AB 1209:

LEGISLATIVE COMMITTEE RE-

On March 30 the VVA California State Council held their second annual legislative day at the State Capitol in Sacramento. This legislative day was in conjunction with Welcome Home Vietnam Veterans Day (WHVVD). WH-VVD is recognized by proclamation of the Governor each March 30. Vietnam veteran and State Assemblyman Paul Cook (R-Yucaipa) carried the legislation to annually recognize WHVVD.

We had a good turnout for this event with more than 40 council members attending. In addition to hearing from legislative and CA Department of Veterans Affairs (CDVA) speakers and taking part in the WHVVD ceremony, attendees also visited their local legislators and urged support for veterans legislation.

During the morning, Assembly and Senate members stopped by to introduce themselves to the Council and to speak about veterans related legislation they are carrying. The Council provided a full breakfast and lunch to attendees. The legislative portion of the day was spent in the Capitol's basement dining area, an ideal location for legislators, committee consultants, staff and members of the Administration to visit the group. During the morning program, the Council awarded its 2010 Legislator of the Year awards to Senator Lou Correa (D-Santa Ana) and Assemblyman Jim Nielsen (R-Gerber) for the outstanding work they did advancing the veterans cause in 2010, CDVA Acting Secretary Rocky Chavez and Deputy Secretaries Ted Puntillo and J. P. Tremblay attended both events. Secretary Chavez spoke eloquently about a theme he calls "standing on the shoulders", whereby the lessons learned by yesterdays veterans benefits the men and women fighting in today's conflicts.

From last year to this year there was a noticeable change regarding the number of legislators that stopped to see us

and speak to our members. Pete Conaty and Associates did a great job in putting this event together. Our members have been doing great work in making contact with their legislators and getting our messages out. In the past we have had numerous workshops on how to speak to legislators but I think hands-on experience like this is the best training. I think our members are getting more comfortable and learning who to speak to about the issues. Although most of the work is best done at the local offices of the legislators, they appreciate us stopping by. Although these meetings are brief, we are letting them know that the support they give us is appreciated and that we are active in legislative advocacy.

At 1130 we took a break from the legislative portion of the Capitol Day to go to the Vietnam Memorial for a short ceremony for Welcome Home Vietnam Veterans Day and the reading of the Governor's proclamation. Our speakers for this ceremony included Secretary Rocky Chavez, Assemblyman Paul Cook, VVA-CSC President Steve Mackey, Senator Correa, Assemblyman Pan, and the invocation was given by Vietnam veteran Chaplain Christopher Garrett (COL. CA). VVA Chapter 500 and the California State Council laid wreaths at the memorial to honor our fallen brothers. After the ceremony it was back to the capital for lunch and meetings with legislators. The California State Commanders Veterans Council (CSCVC) met at the CDVA offices to hold their quarterly meeting. The CSCVC is a statewide umbrella organization of 20 veterans groups of which the VVA-CSC is an active participant. President Mackey, CSC and lobbyist Pete Conaty attended the meeting. Some of the commanders joined us during the morning and at the Memorial. Our Capitol Day, the WHVVD ceremony, and the CSCVC meeting made for a full day. I would like to thank all who attended that day's events and for the unique perspective they bring to our advocacy efforts. Also, when veterans from across the state meet with their legislators and help to show our strength, it brings home the importance of veterans issues to our elected officials.

Since this was only our second legislative day I would like to hear from some of the participants to get guidance on how we can improve in next year's event. Hopefully we can work it out so more members from the southern part of the state can attend. A lot of the members of the Veterans Affairs committees are from the LA and San Diego areas of the state. It would be very beneficial to have some of the leaders of our Southern California chapters attend next year's event so that they may communicate our message to the crucial LA and San Diego delegations.

CONATY RECEIVES AWARD

Pete Conaty, Governmental Advocate For Veterans Receives Cdva Secretary's Award For 2010

Pete Conaty, Veteran's Governmental Advocate, was awarded the California Department of Veterans Affairs Annual Secretary's Award for 2010. The award was given in recognition of Mr. Conaty's distinguished service to the nation and in acknowledgement of his invaluable contributions to California's veterans over the past 15 years as a legislative advocate.

Mr. Conaty is a lobbyist in Sacramento whose firm, Pete Conaty and Associates, represents the interests of California's veterans, as well as other clients, before the State Legislature and state agencies, boards, and commissions. Mr. Conaty, on behalf of veterans service organizations, advocates for the benefits and services that California's 2.1 million veterans and their families have earned by virtue of their service to this country.

"I am deeply humbled and honored by this award" stated Conaty. "Advocating on behalf of veterans is the greatest job in the world".

Conaty has also been honored for his work by the California chapters of the Vietnam Veterans of America, Jewish War Veterans, Military Order of the Purple Heart, and the National Guard Association.

Pete Conaty (Lt. Col. USA-Ret) retired from the Army in 1985 and pursued a second career in the California Legislature. Pete served as a legislative staff person in a variety of positions in the State Assembly. In 1995 Conaty left the Legislature to start the lobbying firm of Pete Conaty and Associates. Pete, who is a Vietnam veteran, is passionate about veterans issues and is known around the Capitol as the "go-to guy" on all things related to veterans and

the military. Pete represents the American Legion, AM-VETS, CAL-MOAA, California State Commanders Veterans Council, California Association of County Veterans Service Officers, Student Veterans of California, and the Vietnam Veterans of America.

Pete and his firm monitor close to fifty pieces of veterans and military related legislation each legislative year as well as assisting veterans clients in the formulation of legislation. Pete is also one of the principal organizers of the State Assembly's Annual Veteran of the Year luncheon.

VVA President Warns: Don't Balance the Budget on Veterans, But Do Focus on How the VA Spends the Funding It Gets

WASHINGTON, D.C. – John Rowan, National President of Vietnam Veterans of America (VVA), told a congressional hearing today, "Just because veterans, and our families, have sacrificed, this does not mean that we are willing to sacrifice in this way again.

"While we understand the need to address the deficit," Rowan said, "We stand 100 percent behind this statement by Congressman Tim Walz: 'Attempting to balance the budget on the backs of veterans who have risked life and limb in service of our country is unacceptable.'

At the same time, Rowan said at a joint hearing of the House and Senate Veterans' Affairs Committees, "A very bright light ought to be shined on the operations of the Department of Veterans Affairs to probe for redundant or duplicative services, poor acquisition management, and staffing inefficiencies. This synchs with one of VVA's overarching priorities: accountability."

The other "top priorities" for VVA, Rowan said, are expanding and enhancing the VA's outreach efforts to inform veterans and their families, not only of the benefits they have earned by virtue of their military service, but also of the potential long-term health effects of toxic exposures; the addition of questions about a veteran's military medical history in all electronic health records; and the creation of a Veterans Economic Opportunities Administration in the VA to "consolidate various currently separate yet interrelated programs whose mission is to assist veterans obtain and sustain meaningful work, or training, or education that will lead to a decent job at a living wage, and will enable veterans to achieve their American dream." Of particular concern, Rowan said, is the lingering legacy of Agent Orange, "We are alarmed for our children and their children who present with birth defects or learning disabilities never before seen in the father's or the mother's family history," Rowan said. "We need research into the longterm effects of toxic exposures, and just as importantly, we need treatment and care for the progeny of veterans exposed to a toxic fog in a combat zone.

VETERANS DECRY PROPOSED CUTS TO COUNTY SERVICES

State lawmakers can expect a bitter greeting next week from military veterans over nearly \$10 million in proposed cuts to already strained local veterans services.

The budget that Gov. Jerry Brown proposed last month would cease state support for the small, backlogged county offices that connect veterans with federal benefits, medical care and counseling.

In Contra Costa County, the cuts could mean the loss of \$90,000 and one of the office's four employees, said Phil Munley, the county's veterans services officer. The impact is uncertain in Alameda County, where a \$360,000 budget funds five staffers, said Michael Ennis, who heads that office.

The January budget also calls for an end to Operation Welcome Home, an outreach program for soon-to-be-discharged military personnel. That program, launched under former Gov. Arnold Schwarzenegger, employs 18 people statewide.

The numbers pale to the state's \$25 billion budget shortfall, about half of which Brown seeks to narrow with cuts. Veterans advocates say the administration is wielding the knife in the wrong place, given the amount of federal money the county offices draw into California for veterans.

The county offices helped veterans collect \$125 million in one-time benefits and about \$170 million in recurring benefits last fiscal year, according to the California Association of Veterans Service Officers. Contra Costa County ranked fifth in the state, drawing nearly \$5 million in one-time federal benefits for 1,180 veterans and an annualized \$6.65 million in recurring benefits.

"I don't blame Governor Brown because he's certainly got huge problems to deal with," said Pete Conaty, legislative advocate for the association. "Our problem is, the Department of Finance just doesn't seem to want to acknowledge that we bring revenue to the state."

With more troops returning from Iraq and Afghanistan, waiting times continue to grow at the county offices. In Contra Costa, demand increases 10 percent or more each year, said Munley, who hopes to increase staffing in outlying areas.

"We're barely holding on with what we got here," Munley said. "I'm not sure the Brown people coming in had a full understanding of what county veterans service offices did, and what we provide. I think they have a better idea now. I have a pretty good feeling this stuff will work out."

Asked about the cuts last week, Brown told a reporter for the San Diego Union-Tribune, "We'll take a look at that."

J.P. Tremblay, deputy secretary of the state Department of Veterans Affairs, said the governor focused on preserving funding for the nearly 2,000 veterans in state veterans homes.

"We did not get hit as hard as some other departments," he said. "It's a tough budget, and we've got to do something."

Veterans advocates are pushing to at least allow the department flexibility over funding the county offices, which also receive money from the counties and veteran license plate revenue. Conaty said veterans plan to swarm budget hearings next week in the Senate and Assembly.

In Alameda County, where the county offices assist a large homeless veteran population, the county is looking for new funding sources, including the VA. The office relies on the county for about 80 percent of its funding, Ennis said.

"We're getting pretty good at begging."

VA Extends Post-Incarceration Health Care

Measure Would Help Reduce Repeat Offenses

WASHINGTON (March 30, 2011) - The Department of Veterans Affairs (VA) will extend health care to eligible Veterans in halfway houses and other temporary, post-in-carceration housing under a new program aimed at cutting back on repeat offenses.

"There's hard evidence that lack of access to health care, including mental health care, for newly released inmates is a factor in people becoming homeless or returning to prison and jail," said Jim McGuire, director of VA's Veterans Justice Outreach Programs. "These are Veterans who otherwise qualify for VA health care."

A long-standing rule has barred VA from providing health care to Veterans for whom another federal, state or local government has an obligation to provide health care. Frequently, that means immates of prisons and jails.

Under the changed rule, that prohibition would be amended and VA would be allowed to provide health care to Veterans in halfway houses and other temporary, post-incarceration housing.

An Urban Institute study in 2008 found that good health care in the first months of community reentry played a key role in easing readjustment and reducing recidivism.

About 29,000-56,000 Veterans are released annually from state and federal prisons, and at least 90,000 Veterans are released each year from city and county jails, according to Department of Justice's Bureau of Justice Statistics.

MIA SEARCH IN CAMBODIA

Teams to Search Cambodia for Vietnam War MIAs From a Joint POW/MIA Accounting Command News Re lease

WASHINGTON, Feb. 4, 2011 - Two archeological teams from the U.S. Joint Prisoners of War/Missing in Action Accounting Command are scheduled to arrive in Cambodia soon to search for Americans unaccounted-for from the Vietnam War, and physicians and nurses from military commands in Hawaii will accompany them to participate in a health engagement mission.

As part of the recovery portion of this dual-purpose deployment, more than 40 recovery team members will excavate a burial site and an underwater aircraft crash site in search of four missing Americans in Cambodia's Kampong Cham and Kracheh provinces.

The deployment, expected to last about 40 days, marks the command's 44th joint field activity in Cambodia, officials soid

Recovery teams search for human remains, life-support items and other material evidence that may further the identification of Americans missing from past conflicts.

In addition to recovery efforts, U.S. and Cambodian personnel will participate in a medical engagement outreach event, treating 4,000 to 8,000 people in rural and highly underserved communities, officials said. The specialized 12-member team of experts in various medical specialties will provide basic health assistance, laboratory services and optometry examinations.

The U.S. medical team members are from Tripler Army Medical Center, the 18th Medical Command and the Joint POW/MIA Accounting Command. U.S. and Cambodian physicians will reinforce medical capabilities by participating in an information exchange, benefitting both countries educationally and socio-culturally, officials added.

"[Tripler] is sending physician residents from OB/GYN and family medicine to conduct expert exchanges with local physicians, and will be invited to work alongside the Khmer physicians and treat their patients," said Army Capt. Drew Webb, a Joint POW/MIA Accounting Command physician assistant.

This will be the first time a Tripler resident program has deployed to a foreign country on a humanitarian outreach mission. Webb added.

"The big takeaway for all of this is that the [Tripler] residents will get training and experience in such a unique environment," he said.

Joint POW/MIA Accounting Command is a jointly manned U.S. Pacific Command organization of more than 400 military and civilian specialists that has investigated and recovered missing Americans since the 1970s, officials said, noting that 1,702 Americans still are listed as missing in action from the Vietnam War.

CA HIGHWAY WAITING FOR VIET-

NAM VETS SIGNS

BAKERSFIELD, Calif. - Drivers would never know a portion of a highway near Bakersfield was renamed for Vietnam veterans in 2006. Signs marking Vietnam Veterans Memorial Highway have never gone up. Some residents are trying to change that.

A group that includes veterans has launched a fundraising campaign to finally erect the signs on the roughly 13-mile stretch of Taft Highway between Highway 99 and Enos

They say people in the community should always remember the sacrifice those veterans made.

"We want to honor all Vietnam veterans in the Kern County area," Mario Muniz, who received a Purple Heart as a Marine in 1968, told the Bakersfield Californian.

The group will need between \$3,000 and \$4,000 to put up the signs. The goal is to raise another few thousand dollars for ongoing maintenance and repairs.

By law, the state is not allowed to contribute to such signage, said Nicolas Esquivel of the California Department of Transportation.

A Vietnam veterans group previously raised money to erect the signs but then folded. Muniz said that group was led by his friend Barney Cadena, a fellow Marine who died in a motorcycle crash a few years ago.

Muniz wants to realize his friend's vision regarding the signs.

"Marines take care of their own," he said.

Organizers said any funds raised will go into a tax-exempt account held by Veterans of Foreign Wars, Post 7216.

There are over 20,000 homeless veterans in the Los Angeles area alone, where the National Veterans Home been broken up, given away and "lent out," piecemeal, to prep schools, a powerful and wealthy Brentwood homeowner and Veterans Park Conservancy, even dotted with oil wells and used to store rental cars. Veterans Today reporter, Robert Rosebrock, an advocate for homeless veterans, was singled out, according to statements from the 15 officers. Rosebrock was illegally arrested based on falsified complaints and perjured statements submitted to the US Attorney in Los Angeles and the Federal District Court. The charges were dropped and Rosebrock later freed.

The ACLU has filed suit against the Department of Veterans Affairs for violating Rosebrock's civil rights in this issue. Attorney Peter Eliasberg represents the ACLU and was not available for statement.

Rosebrock states.

"The powerful Brentwood Homeowners Association and Veterans Park Conservancy have illegally diverted a project for homeless veterans to private use, over a billion dollars of land, while veterans sleep on the sidewalk. Attorney Richard Fox, representing the Annenberg Founda-tion, agrees with Rosebrock. Any private use of this land, for a park or oil wells, it doesn't matter, is not allowed in accordance with deed restrictions and California law. This is our legal opinion, submitted to the Secretary of Veterans Affairs in a 30 page paper. We received a one page answer from Veterans Affairs citing a single court case they say supports their use of the land. In fact, the case said nothing of the sort, a very inappropriate response to an issue so vital to America's veterans

Additional reports indicate that VA funds are being channeled into a money laundering operation, according to whistleblowers inside the Los Angeles VA.

"Phony contracts with nonexistent vendors are paid out to an empty office down the street. This has been going on here for years, hundreds of thousand missing, maybe millions and it is all being covered up. Payments were made to dummy corporations for lab work outsourced by the VA. This is still going on."

Veterans Today has received reports from VA police and other personnel, including audit and accounting, that tell of missing monies, irregularities and fraud.

WEST LOS ANGELES VA IS
FAILING BOTH VETERANS
AND ITS LEGAL OBLIGATIONS

Los Angeles, the city of Angels, has long been known as a place where people come to watch their dreams come true. Sadly, for many it has become a city where they have watched their dreams die on the streets, literally.

It is utterly wrong that those who have served their country in the military now must sleep on concrete sidewalks. The ACLU of Southern California (ACLU/SC) is deeply committed to alleviating the plight of all homeless men and women in California, including those who have served their country in the armed services and now find themselves on the streets.

We have litigated many cases on behalf of homeless men and women; we have challenged the practices of the Los Angeles Police Department in enforcing laws criminalizing sleeping on the streets when there are insufficient shelter beds available and the practice of illegal stops and searches against homeless people in Los Angeles Skid Row.

Our veterans, who are heroes, have been victims of these practices and deservedly should have shelter they can call their own.

In addition, I have personally been working to protect the the use of the WLA VA land under the 1888 deed for land. First Amendment rights of Robert Rosebrock, a 68 yearold veteran, who regularly demonstrates in front of the Veterans Administration in West Los Angeles, protesting its failure to use the land in the manner required by the 1888 deed of land to the United States government for a home for veterans.

The ACLU/SC supports the request for an investigation into whether the VA is failing to abide by the terms of the 1888 deed. That request was made by the Metabolic Studio, LLC, a direct charitable activity of the Annenberg Foundation. Certainly, leasing portions of the VA land to a rental car company to store its cars, and leasing other portions to a local private school for use as tennis courts appears flatly inconsistent with the terms of the charitable

The VA's failure to abide by the terms of the charitable grant is not only inconsistent with the government's legal obligation to abide by the restrictions imposed by the grantor as part of a charitable grant, but it also has enormous human costs.

According to the Los Angeles Homeless Authority (LAH-SA) Commissioners 2009 Greater Los Angeles Homeless count, there are approximately 42,694 homeless people in the County of Los Angeles, excluding Long Beach and Glendale. Homeless veterans number about 6,540 or approximately 15% of the homeless population of the area, according to the same count.

An article in the Los Angeles Times stated, "Los Angeles remains the nation's homelessness capital." See "Solving Homelessness Will Require Cooperation," Los Angeles Times, November 9, 2010. This crisis is a shameful reality. Indeed, the sight of homeless veterans sleeping on the sidewalks outside the VA land in West Los Angeles not only highlights the necessity of an immediate investigation of how the VA is using this land, but serves as a reminder of the plight of many veterans who have made great sacrifices for this country.

The ACLU/SC believes that requiring the VA to abide by the terms of the 1888 deed could be an important component in realizing Secretary Eric K. Shinseki's vision of ending homelessness for veterans, at least in the Los Angeles area. ACLU Joins the Fray: Calls for Investiga-TION INTO HANDLING OF WEST LA VETS LAND USE DEAL

VA Director Pulls The Plug By Katharine Russ

The American Civil Liberties Union of Southern California (ACLU) has added its support to the Metabolic Studio, a direct charitable activity of the Annenberg Foundation led by artist Lauren Bon, in calling for an investigation into alleged multiple breaches of fiduciary responsibility surrounding the 1888 deed for land donated by Senator John P. Jones and Arcadia Bandini de Stearns Baker for a Veterans' Home, now known as the West Los Angeles VA (WLA VA).

Bon and her team ran a widely acclaimed, fully funded and compensated work therapy (CWT) program for veterans known as Strawberry Flag, for over a year on the WLA

This work was located between three under purposed buildings, 205,208 and 209. The work was allowed under a Memorandum of Understanding (MOU) agreement with Asset management. The MOU was signed by the Director, Donna Beiter of the WLAVA, and was extended due to its popularity with both clinicians and veterans.

Despite the success and many benefits it offered to veterans, Beiter abruptly pulled the plug on the Strawberry Flag project in October 2010.

Bon's support of veterans didn't end, however, when her Strawberry Flag project was terminated. Instead, the Metabolic Studio focused on the VA's failure to meet its fiduciary responsibilities to our country's veterans imposed on

The Metabolic Studio recently, released a 30-page "position paper," supported by an historical background, USGS maps and extensive case law, asserting the VA's breach of trust in failing to use the WLA VA as a "permanent home" for veterans as required under the 1888 deed and outlined several impermissible uses of the land.

The position paper states "Access of veterans to at least 110 acres of the land at the WLA VA is either forbidden or restricted by land-sharing agreements that the VA has entered into with commercial and other organizations. This use of the land is not in conformity with the requirement under the 1888 Deed that the donated land be used in a manner that directly contributes to its use as a home for veterans, and is therefore not permissible." Richard L. Fox, of Dilworth Paxson LLP, a recognized legal expert in the fields of philanthropy and charitable giving, assisted in the preparation of the paper.

The Veterans Health Administration (VHA) Handbook 1820.1 Section 4(k) states that if a Sharing Agreement exceeds five years, such agreement does not qualify under Title 38, U.S.C. Section 8153 that permits only the sharing of "health care" resources. Nearly all the sharing greements shown in the Draft Master Plan published in the Federal Register on January 19, 2011 exceed five years and are not health care related.

Among the questionable sharing agreements is the 16-acre tract of land that is to be "Veterans National Park"- a public park to be open to the neighboring Brentwood community. The land was awarded rent-free to the Veterans Park Conservancy (VPC), which is not a Veterans Organization, for a period of twenty years.

An agreement signed by Sue Young, Executive Director of the VPC and Ralph Tillman, Director of Asset Management of the WLA VA, incorrectly describes the 235.5 tract of land conveyed to the "National Home for Disabled Volunteer Soldiers" when, in reality the proposed site is on a portion of the 300 acres of land donated under the 1888 deed.

The Sharing Agreement signed by Young and Tillman for a 20-year period is clearly not permitted under Title 38 U.S.C. Section 8153.

development stage in compliance with the legal requirements set forth by Federal rulings, Veterans Administration Policies and Guidelines established by the General Services Administration (GSA)." The GSA is shown on the VPC website as a direct supporter of the VPC.

Neither Tillman nor Young would avail themselves for

Recent tax returns filed with the IRS, that are public record, reveal that Young is paid an annual salary exceeding \$100,000 plus expenses by the VPC, a relatively tiny organization with rather limited activities. Young resides in Tucson, AZ.

According to her office, U.S. Senator Diane Feinstein, listed as a VPC supporter, has not had contact with VPC for a few years but rather has focused her attention on Building 209 on the WLA VA campus which the VA has committed \$20 million for conversion into a homeless facility which may house 80 veterans- a building that in 2008, the

VA said would require \$7.2 million to repair. U.S. Congressman Henry Waxman, who supports the VPC, also did not respond to requests for comment.

Robert Rosebrock, Director- Old Veteran's Guard, along with several Veteran Service Organizations (VSO) have denounced the use of sharing agreements and have fought the VA for many years over these issues. Outside the proposed park that was scheduled for completion in 2008, Rosebrock and several veterans have stood in protest to the use of the land as a public park for 153 consecutive Sundays.

Rosebrock emphasized that The Act of Congress of March 2, 1887 and the language of the 1888 Deed clearly indicate the intent for a National Home for veterans- not a public park where HOMELESS veterans are likely to be ostra-

Rosebrock points to the 20,000 homeless veterans in the Los Angeles area whom he says, "have been exiled and dispossessed from their rightful Home and are forced to survive, hungry and homeless, on the dangerous streets of Los Angeles while the very people who have exiled them, live in multi-million dollar mansions."

Peter Eliasberg, ACLU Managing Attorney, who is defending Rosebrock in a Free Speech lawsuit against the VA, wrote in a February 2011 letter to General Eric K. Shinseki (USA Ret.) Secretary, Department of Veterans Affairs, "The Veterans Administrations failure to abide by the terms of the charitable grant is not only inconsistent with the governments legal obligation to abide by the restrictions imposed by the grantor as a part of a charitable grant, but also has enormous human costs.

"The sight of homeless veterans sleeping on the sidewalks outside the VA land in West Los Angeles only highlights the necessity of an immediate investigation of how the VA is using this land."

The Annenberg Foundation which gave \$1,000,000 to the VPC to complete the Women's Rose Garden, dedicated on December 5, 2010, but which remains locked to this day, has pulled its support for the VPC.

A letter from Bon, who is a Director of the Annenberg Foundation, to Young, requested that they not be identified in any manner as a donor to the VPC or the National Veteran's Park. It said, "While we support the creation of public parks and the preservation of open space, the use of the land donated under the 1888 deed for a public park does not directly contribute to the use of the land as a permanent home for veterans and is contrary to the 1888 deed

The Veterans Caucus and Executive Board of the of the California Democratic Party took a stand similar to the Annenberg Foundation, notifying the VPC that it does not endorse a public park on the WLA VA land and that the land should be limited only for veteran uses.

Carolina Winston Barrie and Ricardo Bandini Johnson, direct descendants of Senator John P. Jones and Arcadia Bandini de Stearns Baker, questioned, at length, the provisions of the VA's recently released Draft Master Plan which confirms the continued use of the WLA VA land for non-veteran purposes

In a letter to the VA, Barrie and Johnson said, "This is not what our ancestors intended when they contributed this


