



National POW/MIA Recognition Day

SEPTEMBER 16TH 2011



Each year the President of the United States issues a proclamation designating the third Friday of September National POW/MIA Recognition Day. All military installations of all branches of the service and all Navy ships in port or at sea are ordered to fly the POW/MIA flag and conduct appropriate ceremonies to honor this nation's POW's and memorialize those who are MIA. Though not required or obligated to, many communities throughout the country also hold

observances of our National POW/MIA Recognition Day. Many states now have officially recognized this day and require the POW/MIA flag to be flown at state government facilities. Also, most veterans' organizations, locally and nationally, observe this day in various ways. Some sponsor and staff elaborate events complete with parades, celebrity and dignitary speeches and appearances, and performances by local or nationally known performers. Each year, National POW/MIA recognition day is more widely observed, receives more media coverage and attracts more attention.

Since it's founding, American youth and treasure has fought and died protecting our freedoms and way of life and preventing the expansion of totalitarian and evil regimes. Our country suffered tremendous casualties in our Civil War and two World Wars. In each of our wars, our men and woman have been killed, wounded, taken prisoner or have become missing. But it has only been recently that the sacrifices of those taken prisoner or those that were declared Missing in Action have been officially recognized.

It is appropriate that this country, this nation, honor and pay tribute to those who endured the hardship, torture and anguish of being a POW and recognize the story without end of those who are MIA. We can only begin to imagine the anxiety and anguish of the families of those MIA who are often left to wonder and speculate on the fate of their loved ones forever, with no closure possible.

HISTORY of the POW/MIA FLAG

In 1971, Mrs. Michael Hoff, an MIA wife and member of the National League of Families, recognized the need for a symbol of our POW/MIAs. Prompted by an article in the Jacksonville, Florida Times-Union, Mrs. Hoff contacted Norman Rivkees, Vice President of Annin & Company which had made a banner for the newest member of the United Nations, the People's Republic of China, as a part of their policy to provide flags to all United Nations members states. Mrs. Hoff found Mr. Rivkees very sympathetic to the POW/MIA issue, and he, along with Annin's advertising agency, designed a flag to represent our missing men. Following League approval, the flags were manufactured for distribution.

On March 9, 1989, an official League flag, which flew over the White House on 1988 National POW/MIA Recognition Day, was installed in the U.S. Capitol Rotunda as a result of legislation passed overwhelmingly during the 100th Congress. In a demonstration of bipartisan Congressional support, the leadership of both Houses hosted the installation ceremony.

The League's POW/MIA flag is the only flag ever displayed in the U.S. Capitol Rotunda where it will stand as a powerful symbol of national commitment to America's POW/MIAs until the fullest possible accounting has been achieved for U.S. personnel still missing and unaccounted for from the Vietnam War.

On August 10, 1990, the 101st Congress passed U.S. Public Law 101-355, which recognized the League's POW/MIA flag and designated it "as the symbol of our Nation's concern and commitment to resolving as fully as possible the fates of Americans still prisoner, missing and unaccounted for in Southeast Asia, thus ending the uncertainty for their families and the Nation". The importance of the League's POW/MIA flag lies in its continued visibility, a constant reminder of the plight of America's POW/MIAs.

Other than "Old Glory", the League's POW/MIA flag is the only flag ever to fly over the White House, having been displayed in this place of honor on National POW/MIA Recognition Day since 1982.

With passage of Section 1082 of the 1998 Defense Authorization Act during the first term of the 105th Congress, the League's POW/MIA flag will fly each year on Armed Forces Day, Memorial Day, Flag Day, Independence Day, National POW/MIA Recognition Day and Veterans Day on the grounds or in the public lobbies of major military installations as designated by the Secretary of the Defense, all Federal national cemeteries, the national Korean War Veterans Memorial, the National Vietnam Veterans Memorial, the White House, the United States Postal Service post offices and at the official offices of the Secretaries of State, Defense and Veteran's Affairs, and Director of the Selective Service System.



National POW/MIA Recognition Day

The President issues a proclamation commemorating the observances and reminding the nation of those Americans who have sacrificed so much for their country.

Observances of National POW/MIA Recognition Day are held across the country on military installations, ships at sea, state capitols, schools and veterans' facilities. It is traditionally observed on the third Friday in September each year. This observance is one of six days throughout the year that Congress has mandated the flying of the National League of Families' POW/MIA flag.

POW/MIA Table Ceremony

The POW/MIA Table Ceremony is highly symbolic and is performed reverently at a table set with very specific items symbolizing the ordeal of POW's and paying tribute to those who are MIA. The script for the ceremony is somewhat flexible to allow for local circumstances and the formalized list of table items can also vary depending on local circumstances, the organization performing the ceremony and people available to conduct it.

Current Status of Unaccounted-for Americans Lost in the Vietnam War

Of the remaining 1,294 Americans still unaccounted for in Vietnam, 587 are in a “no further pursuit” category. This means that as a result of rigorous investigation, we have conclusive evidence the individual perished, but do not believe it possible to recover the remains.

Repatriating and Identifying Remains

- The Joint POW/MIA Accounting Command (JPAC) plans to conduct four Joint Field Activities (JFAs) this fiscal year in Vietnam. Each JFA involves approximately 95 U.S. personnel plus their Vietnamese counterparts. Together, they work on investigations and excavations throughout the country for a period of approximately 30 days.
- American remains are transferred to JPAC’s Central Identification Lab in Hawaii for positive identification by forensic anthropologists.
- The 103rd JFA began May 9 and will continue through June 22, 2011. Recovery teams are excavating sites in Quang Binh and Quang Tri Provinces, as well as off the coast of Thua Thien-Hue and Thanh Hoa/Nghe An Provinces.
- The 104th JFA is schedule to begin August 5 and continue through September 7, 2011. Recovery teams are scheduled to excavate sites in Quang Ngai and Quang Nam Provinces.

CFL’s—They Create More Problems than they Solve!

Did you know?: CFL’s take more glass to manufacture than Edison’s regular old incandescent bulb, which requires more use of energy, about 5 times as much energy, as manufacturing the glass for the incandescent bulb. CFL’s contain Mercury (Hg) which is a hazardous and highly volatile atmospheric pollutant which requires strict cleanup procedures if you drop and break one. Used CFL’s will cause serious land fill contamination problems when disposed of. All CFL’s are manufactured in China, increasing our already staggering indebtedness to that country’s communist regime. They cost almost 5 times as much to purchase as incandescent bulbs. They give off a harsh white light that creates a home atmosphere more like an office or train station than a home.

The outreach workers were surprised because Bill has always been a "loner". I was touched and told Bill that I would come by to see him. And I have and will continue to do so. There are other veterans in our Valley that need some company once in a while and some connection to the veteran community. We can all do that. So be on the lookout for the opportunities. It is really the small everyday things that we can do that can make a difference in the lives of veterans. You will be blessed.

NO legitimate agency of the government or legitimate business will ever ask for personal info on the phone.

The "Operation Ranch Hand" unit patch. Designed in 1962, its meaning was: Red letters on a yellow field represents the colors of Vietnam. The encircling green ring, combined with the red and yellow, represents the Vietnam Service Medal. The center green field represents the jungles of Vietnam and the brown swath through the middle represents a defoliated area. The white characters in the center of the brown swath are the Chinese characters for the color purple, the color code for the first defoliant used in Vietnam. The black 55 gal drums were painted with a wide colored band at the top, with the colors indicating the type of defoliant contained in the drum.

The defoliant most used in Vietnam had a colored band of orange, thus the term, "agent orange". Other defoliants were coded with purple, blue, red and green bands on the drums, and were referred to as agent blue, agent orange, etc. Of all the defoliants used in Vietnam, the most effective at defoliating the heavy jungle growth was, you guessed it, agent orange. Unfortunately, it contained high amounts of an impurity we now know was "dioxin".

California Department of Veterans Affairs

Sacramento— A new program initiated by the Department of Motor Vehicles (DMV) and the California Department of Veterans Affairs (CalVet) will help connect veterans in California with the services and benefits they have earned through their prior or current service in the U.S. Military.

When a Californian applies for a new driver's license or renewal, or if they apply for an identification card, they will notice on the new application forms a check-off box that will permit the DMV to share the applicants contact information with CalVet. The veterans will then be sent information that gives a brief outline of services and benefits and includes a postage-paid reply card that the veteran fills out and returns to CalVet. Once the card is received the veteran will automatically begin receiving information about services like education benefits, employment assistance, disability and compensation payments, health care benefits and much more.

"The most challenging thing we have to do in this department is to ensure that veterans in California are educated about the benefits and services that they have earned through their honorable service in the military," said CalVet Secretary Peter J. Gravett. "This partnership has the potential to help our department connect with nearly every one of the nearly 2 million veterans living in this state." Under the program initiated on July 1, U.S. veterans residing in California can simply check a box on the form to approve having benefit information sent to them by CalVet.

CalVet Services, through its "CalVet Connect" initiative has as its guiding philosophy that programs of benefits to veterans fulfill necessary, proper, and valid public purposes by promoting patriotism, by recognizing and rewarding sacrifice and service to country and by providing needed readjustment assistance to returning veterans and their families, whose lives were interrupted when they responded to their country's call to military service.

This program offers CalVet the opportunity to inform veterans and their dependents about veterans benefits and how to obtain these benefits through the process of application and representations of claims. CalVet's partnership with DMV augments this program by allowing many military and service members the opportunity to share their contact information with CalVet so that appropriate benefits information can be provided to them.
